**READ BEFORE ACCEPTING**

An administration fee of \$50 will be applied to ALL OVERDUE payments and NSF cheques. A \$50 Late Fee will be charged on all accounts over 30 days. If payment has not been received within 60 days, Dancers will not be permitted into Class. Outstanding balances will be due upon notification of withdrawal. All accounts must be up to date in order to participate in the Year End Recital.

**NON-REFUNDABLE FEES**

Registration fees are non-refundable. Summer Camps, Summer Classes & Summer Intensive Fees are non-refundable. Costume Fees are non-refundable as of **November 1, 2024**. Competitive Costume Deposits are non-refundable and Family is responsible for full Balance of Costumes as of **October 1, 2024**.

**CANCELLATION POLICY**

**No refunds/cancellation after February 28 2025.**

Prior to February 28, 2025, upon notification of withdrawal, families forfeit tuition of the current **TERM**.

TERM 1: September 1, 2024 - November 30, 2024

TERM 2: December 1, 2024 - February 28, 2025

TERM 3: March 1, 2025 – June 6, 2025

Only future tuition payments will be returned/stopped. There will be no reimbursement of a partial term of classes.
